

THE NATIONAL CHENGCHI UNIVERSITY FUND AT GIVE2ASIA: HOW TO GIVE



This document outlines how donors can support the National Chengchi University in Taiwan with U.S.-based assets by making tax-deductible contributions to Give2Asia. Donors making contributions with assets in Hong Kong should contact Give2Asia to receive additional information about receiving eligible Hong Kong tax deductions.

Background

Give2Asia is a US-based social enterprise that serves as a catalyst for philanthropic investment in Asia. Give2Asia makes international philanthropy safe, effective and impactful for corporations, foundations and individual donors. For many Asia based educational and charitable organizations, Give2Asia's fiscal sponsorship offers a convenient, quick and cost-effective way to accept tax-deductible contributions from supporters in the United States.

Established in 1927, National Chengchi University is noted for its humanities and social sciences disciplines and currently houses nine colleges, including Liberal Arts, Science, Social Sciences, Law, Commerce, Foreign Languages & Literature, Communication, International Affairs, and Education; 33 departments, 2 BA modules, and 48 graduate institutes, with 32 institutes offering PhD programs, 16 on-the-job master's programs, and 5 English-taught degree programs.

Notable aspects of the National Chengchi University Fund include:

- **Gifts for the National Chengchi University Fund are tax deductible.** Give2Asia is recognized as a tax-exempt charitable organization in the United States (ID# 94-3373670). As such, donations are tax deductible according to U.S. law. Please consult your financial advisor on structuring your giving for maximum tax benefit.
- **You will receive a thank you letter and receipt in recognition of your gift.** Upon receiving a gift, Give2Asia will issue a thank you letter and receipt recognizing your gift for the National Chengchi University Fund. This letter may be used for tax reporting purposes.
